1. Safe Routes to School (Charles Wilson)
 - a. SR2S is part of an international movement to help kids walk and bike to school. A team of people associated with the school is brought together to help plan safe routes. These people are usually from or associated with local law enforcement, planning, road commissions, the school, and parents.
 - b. This is the first year for a SR2S program in Ypsilanti
 - c. Walking audits are conducted in the area around the school by members of this team- they look for safety issues (ie, vacant houses), barriers to walking/biking (ie, lack of curb ramps)
 - d. Then use this data to make improvements- funding received through federal grants

 2. City Vacant buildings list- how to report, map of existing ones (Teresa Gillotti)
 - a. The fire department keeps a list of vacant properties, and checks monthly
 - b. If you know of a vacant property, let the building department know so that they can add it to their list and check it out! 734-482-1025.

 3. Community Gardens- call Growing Hope for more information on how to start one! They can use vacant lots, front yards (with permission)- if you have a site in mind, give them a call, and they can help you determine if it's suitable.
